We hope everyone has kept well over the winter! Hopefully we will be able to open as usual and looking forward to seeing everyone again! For those of you who paid \$1000 to stay away, due to Covid, this option is not available this year. Opening date is May 1<sup>st</sup> and closing is September 30<sup>th</sup>.

The rate for this year is \$2300.00 plus tax (345.00) for a total of \$2,645.00. A minimum payment of \$1,500.00 is required by May 1<sup>st</sup> and the balance ( minus deposit paid in 2020) by May 31, 2021..

**Payment can be made by cash, cheque, debit, credit card or email transfer**

IF FULL PAYMENT IS MADE BY MAY 14th YOU WILL BE ENTERED IN A DRAW FOR A FREE LOT to take place on Saturday May 15, 2021 in the hall at 11:00 a.m. You cannot qualify for the draw after May 14th.** The winner will be given their money back in the manner in which the lot fee was paid. Outstanding accounts on and after June 1<sup>st</sup> will be charged an additional \$50.00 per month and thereafter. There is also a \$50.00 charge for any NSF cheque.

If you are selling your trailer, the lot fee must be **PAID IN FULL** by May 1<sup>st</sup>. If your trailer sells over the winter please inform the new owners of our rules and regulations. No trailer can be sold on a lot if it is 25 years or older. A deposit of **\$250.00** to secure your site for 2022 is required by September 1<sup>st</sup>, 2021. This deposit is deducted from next years lot fee. Should you decide not to return, the \$250.00 deposit is non-refundable. Your deposit cannot be transferred to another person if you sell your trailer over the winter. If the deposit is not made, we will assume you will not be coming back and your site will be shown to anyone interested in a seasonal site for 2022.

**QUIET TIME** is **12:00 O'clock** midnight on Friday and Saturday nights and 10:00 p.m. Sunday to Thursday. There will be **ZERO TOLERANCE** for late night noise after quiet time. Please be considerate to your fellow campers. No excessively loud music during the day or night! No outdoor amplified music or karaoke machines. All children under the age of 12 must be on their own site or area by **11:00 pm**, teenagers by **12:00am**! You are responsible for the actions of your children and guests! **No Bicycles or Golf Carts** to be driven after dark except for campground personnell. No Driving of vehicles after 11:00pm. Please stay on the main road when walking, not between trailers!

Picnic tables and fire buckets are not provided by the campground. You are responsible for mowing your grass. Lawn mowers and gas is provided for your use.

**DOGS** are to be tied up or kept on a leash at all times. **PLEASE CLEAN UP AFTER YOUR PET.** No animal is allowed to travel on anyone elses' property. Please keep your dog on the main road when

walking them. **No aggressive animals ( pit-bulls, rotweillers, german sheppards, Dobermans) allowed in the campground .** Dogs should not be left unattended outside or inside your trailer. Please control excessive barking from your dog!

**DECKS** not to exceed total length 24'X 10' or 8 x 30, to be made in two sections. No deck can exceed the length of the trailer. All slides are to be incorporated in this measurement. Any new decks or alterations to existing decks must be approved by management in writing before construction begins. Plans & materials must be submitted. Rollershades are permitted but only 2. They can be installed on either end of your deck, or in a corner secured inside your deck and cannot exceed 8ft per shade. Only 2 shades down at a time.

**SHEDS** can only be 8'X 8' or smaller. (no exceptions) All new sheds have to be made of plastic or metal. Please see management before purchase or installation. Wooden sheds in existence cannot be altered or relocated to another site. Sheds in poor condition must be torn down.

**TENTS** are not allowed to be put up on a seasonal site.

All visitors must park in the parking lot and **MUST REGISTER** with the office. All vehicles in the parking lot must display a **VISITORS PASS** in the window. The only vehicles permitted in the campground must belong to the owners of the trailer. Children with vehicles must park in the parking lot. Visitors (with the exception of moms, dads, grandparents and children) must pay to visit. The visitor fee for adults (19 and older) is \$5.00 whether you stay overnight or just visit for the day. You are responsible for the actions of your guests. There is no charge for children 18 and under. **NO** visitors cars allowed in the campground.

**ATV'S** must remain on your truck or trailer at all times. **No off-loading in the parking lot. NO** children's motorized, battery or electric powered vehicles are permitted in the park! Scooters for mobility purposes are permitted.

**IMPORTANT:** Your gate pass is for your use only. They are not transferable to your children or friends. The fee for replacement cards is \$20.00. If you have 2 vehicles you need 2 gate passes. If you leave, your gate pass must be returned within that year or no refund will be given. The gate pass has to be in good condition for a refund. Please note we are not held responsible for any injury , theft, etc. that may occur in the campground. Swimming in the river or pool is at your own risk. Please read your power meter on your last day of camping. All outstanding debts to be paid before you leave.

Due to Covid-19 masks are mandatory when entering the building at all times. This will be enforced! We will know more about restrictions as time gets closer and will keep you informed.
